I Was Just Thinking...



I remember the day when my dad brought home our first video game. It was this rather large yellow rectangular looking contraption with four buttons: an on/off switch, a wide screen/narrow screen switch and two knobs. It sat on the coffee table and you had to hook up some wires to the back of the TV. When you turned it on, a black and white tennis-court looking image appeared with the word "PONG" on it. My brothers and I played for hours,

bouncing a digital ball back and forth against video paddles that looked like small 2x4's. The variation of the game was a faster ball, and a smaller paddle. My, what a long way technology has come in 35 years!

I have always marveled at video game technology, not really understanding how it works, but appreciating its entertainment value nonetheless. I don't know how to program games or computers, but know they are supposed to work when you push certain buttons or move certain controllers, and crying foul and "no fair" when they don't do what they are supposed to do at the right time. As much as I played them when I was young, and sometimes still do (with Sammy and without him!) I always enjoyed playing outside better, knowing that being a part of a real team with real people, playing real games was infinitely more exciting than any video game out there. If only there were video games grown-ups could use every day...

Oh yes! There is! It's called a "smartphone", a "tablet", or more technically speaking, a video/internet platform, where anyone can manage their day in front of some screen that isn't an old television in your family room. And guess what? I have three of them; a smartphone, a tablet and a laptop! Armed with my technology, I bravely face the world, ready to do battle against all spiritual detractors, foreign or domestic. I have become, as I am sure many of you have as well, quite dependent on our little devices to stay connected to the world and to each other, to stay informed and, at the very worst, to deal with our boredom.

Over the past few years I have struggled to find some context for living so plugged in. What does Judaism have to say about technology and being so connected, so intimately, in so many different ways? I mean, does anyone on Facebook really care that I had two lattes before lunch?

According to Dr. Daniel Eisenberg, the beginning of the Torah describes the creation of man and woman, telling us that "God blessed them and God said to them: 'Be fruitful and multiply, fill the earth and subdue it; rule over the fish of the sea, the birds of the sky, and every living thing that moves on the earth.'" Man was created with a mission to rule over the world and to subdue it. Traditionally, this has been interpreted to mean that we are to understand our world in order to master our environment. We are commanded to build bridges and to move mountains in order to improve our quality of life. There are even specific passages in the Torah that command us to heal, giving us a mandate to pursue technology that will heal the sick.

We take this mandate very seriously. It is a mistaken form of religiosity to believe that man should not try to improve his lot. This mandate to manipulate the environment also comes with a sense of responsibility. Man is given a twofold mandate. While he

is instructed to "subdue" the earth and to "rule over" the rest of creation, he is also placed in the Garden of Eden "to work it and protect it." While he was granted permission to exploit and utilize all of the world's natural resources, he is still clearly barred from acts of indiscriminate destruction and waste. Man is enjoined to protect the world and not harm it.

In a famous argument made by the Roman general Turnus Rufus, in his debates with Rabbi Akiva, he asked Rabbi Akiva why Jews circumcise their sons. Do Jews believe that they can improve on God's creation of man?

Rabbi Akiva placed grain and bread before the general and asked him which one he would prefer to eat. The general made the obvious choice and took the bread, which clearly represented man's improvement on nature. Just as baking bread is an act of improving wheat, so is circumcision an act of improving man. The moral of the story is that our mandate is to improve the world. Judaism does not consider the world to be complete without the input of man. We are partners in creation in all aspects of the world, including technology.

The Torah and Jewish tradition seem to imply that we must also use technology for noble purposes. It is the immoral application of technology that is "off limits" to us. The development of technology has always been welcomed by Judaism because technology is ethically neutral. Questions of ethics are questions of applied technology. When Cain brings a sacrifice from inferior produce and his sacrifice is rejected, he is warned that man has

free will to do with his gifts as he sees fit. God's only requirement is that man use his gifts wisely and appropriately. Our job is to decide when it is moral to use the new procedure and when restraint should be applied. Our greatest challenge is applying the fruits of our God-given inquisitive nature in an ethical way. Every new breakthrough offers both hope and change. What we do with it is up to us.

Armed with this idea of technology being ethically neutral, I realized that my attempting to live offline in an

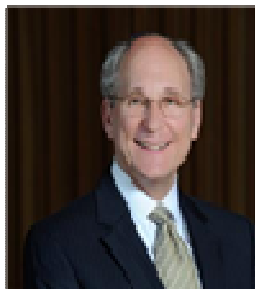
online world does not have to be the only response to the world; rather, there are moments when being connected, sharing a message to my 539 Facebook friends and 14 twitter followers, not to mention my untold number of linkedin connections is important and crafting the right words could bring a needed moment of relief or inspiration (at least I hope so!).

To that end I would like you to know that I have my own blog called "I Was Just Thinking..." which can be located at www.rabbip.com where I will be posting thoughts and ideas where I seek comment and input. I will be adding a new thought every couple of weeks beginning Friday, December 7th. In addition, I do have a twitter account, where I can be reached at @askrabbip, where I will be tweeting a Shabbat message, also beginning December 7. While I do have a Facebook account, I rarely use that for messages and email, as I prefer text messages to come through my cell phone and email to come through apaley@templeshalomdallas.org or askrabbip@aol.com (I know...does anyone still use AOL?).

I look forward to being connected in new ways to you and others and to use this technology for good, beyond games and personal boredom distracting purposes. See ya in person, online, on Skype, Facetime, or whatever medium we stumble upon!

Most of us know the joy of singing together - an experience that used to be part of a family's life when adults and children would gather around the piano in the parlor and sing the popular songs of the day. 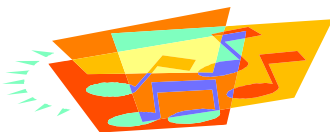
The late Debbie Friedman continued to add to her portfolio right up until her untimely death two years ago. As she made it clear early in the 1970's, contemporary Jewish music is just as effective on adults as it is on children of all ages. Because of her ability to communicate Jewish spirituality, others began and continue to write music that is more American pop than some call Jewish Rock.

In the late '70's when I attended cantorial school and was exposed to the contemporary Jewish music genre, I knew it was another venue to attract people to congregational singing. Traditional melodies have their place, but to keep children and young adults engaged in meaningful worship we also need to offer music that speaks to them in terms of what they are exposed to outside the box of the sanctuary. Some may feel that this is a sell-out to common, unsophisticated music, but I say if it attracts people to our "pews" so be it. It happens to be the trend in Conservative synagogues as well.

In our *Erev Shabbat* service you can hear music by not only Ms. Friedman but by composers whose names may be known only by our campers because these musicians visit Jewish camps all over the country every summer. I am not just speaking of Reform camps, either. They perform at Conservative camps, too. We sing melodies by Jeff Klepper and Dan Friedlander, Rick Recht, Craig Taubman, Julie Silver, and Dan Nichols. Now we are adding to our music repertoire with Josh Nelson, our Composer-in-Residence, who will be here for the *Erev Shabbat* service on January 25th and performing with "The Josh Nelson Project," his band, on Saturday January 26th.

Josh serves as the music director for the URJ Biennial Convention. Those who attended the last convention will remember him as the performer who kept those attending engaged while waiting for President Obama to make his appearance. Josh is also on the faculty for the Hava Nashira Music Institute and a musical artist in residence for the JCC Maccabi Artsfest.

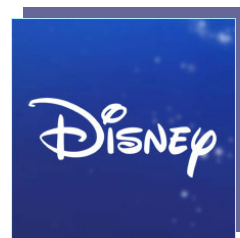

The President's Perspective

As we close in on the end of 2012, I'd like to share a few thoughts regarding Temple Shalom, our leadership and our future. Some of this may sound a little cliché but, hopefully, it will remind us of what we already know.

First and foremost, we have a very healthy, dynamic congregation with committed lay-leaders, volunteers, teachers and students. Our Temple leadership is made up of committed Temple members with a wide variety of personal Jewish journeys. Perhaps most importantly, our current Board of Trustees, as the elected leadership of Temple Shalom, includes men and women who have Temple Shalom's best interests at heart. We don't always agree on every detail, and we wouldn't be much of a Board of Trustees if we did, but collectively, we are working hard to keep Temple Shalom headed in a strong, positive direction. We are blessed to be led by Rabbi Paley in our sacred partnership between clergy and congregation and Steve Lewis, our tremendous Executive Director. Over the past many years, Cantor Croll has shared his heart, voice and teaching with us and both Debbie Massarano and Barrett Harr have been tremendously instrumental in leading our lifelong learning – for children and adults. We are very fortunate to have such a dedicated, caring staff providing assistance and logistical support to all of us.

Over one year ago, Immediate Past President Steve Enda appointed a task force, chaired by Past President David Lynn, Past Executive Committee member Julie Eichelbaum, current Vice President Mitch Hurwitz and current Board member Josh Goldman. The goal of this task force was to examine the services being provided to our congregation and to evaluate how best these services could be provided, from a staffing model standpoint. This task force, with the assistance of a hired professional, conducted a survey, supervised focus groups and reported to the Board in the spring. At the time of their work, the extent and timing of clergy and senior staffing changes was unknown, but planning and anticipatory evaluation took place. The results of the survey showed us that we, as a congregation, do many things well. We love music, learning and connecting with other families sharing Jewish values.

Over the past several months, we have been advised that Cantor Croll will retire and Debbie and Barrett have decided to move on to different personal and professional opportunities. Temple Shalom has initiated a search for not only a new cantor to succeed Cantor Croll, but also a new rabbi-educator, to provide multi-faceted support and leadership to our team of clergy and senior staff. Between these professionals we look to provide a seamless transition from the years of growth provided by Cantor Croll, Debbie and Barrett.

The search committee consists of Temple leaders including young adults, relatively young adults and those with more chronological experience. We have an enthusiastic group of qualified, committed Temple members with a variety of personal and professional backgrounds. I would like to acknowledge those who volunteered for this committee — not being selected does not minimize the importance of their commitment or their ability to serve.

In addition to the expanded search, your Board is discussing The V'Ahavta Initiative. This is a values-statement concept whereby tuition for religious school would be eliminated with the costs absorbed by our entire Temple community. The values-statement would be clear, "Religious School education for our children is the future of Judaism." The financial impact would be shared by a modest annual increase of approximately \$300 per member family. The V'Ahavta Initiative is an interesting and differentiating model that would separate us from other area Reform congregations, hopefully providing yet another reason for potential members and families to join Temple Shalom. We recognize that this concept may be somewhat controversial but, as was recently and extensively discussed at our November 18 Town Hall meeting, it has significant support. As we move forward with these discussions, we hope to hear from you; additional Town Hall meetings will be held and the members of the Board, Executive Committee and I are available to talk more about this proposal. A decision regarding this proposal has not been made at this time. We are continuing to determine how to best implement a concept like this proposal, if at all, at this time.

We have learned a lot over the years and especially over the last 12 months. We are taking these "lessons learned" as we move forward in ways designed and intended to help all of us be better people and a better, stronger Temple community.

Thank you for your continued support and involvement in the present, the past and the future of Temple Shalom!

Report from the Search Committee

The membership and scope of the search committee has been expanded to encompass the search for a Rabbi/Educator. The following people have been added to the committee: Betsy Anderson, Julie Eichelbaum, Kay Krause, Robert Quint and Rebecca Weprin.

A few members will be going to New York in mid-January to interview Rabbi/Educators who will be ordained in May. Students from all three HUC campuses will be in New York for three days of interviews with congregations from all over the country. We are also posting the position for experienced rabbis.

Constitution Evolution

This month, as we continue the evolution of our constitution, we look at Article 5. We are looking at a few issues this time.

We have underlined the proposed changes/additions to this article below.

OFFICERS AND THEIR DUTIES

Section 1. The officers of the Congregation shall consist of a President, three Vice-Presidents, a Secretary, a Financial Director and a Treasurer, and such other officer positions as may be created from time to time by the Board of Trustees. All officers must be a member of the Board of Trustees at the time of nomination or have been a member of the Board of Trustees within the previous three (3) years, be a member in good standing of the Congregation and be of the Jewish faith. The Officers, together with the Immediate Past President, shall constitute and serve as the Executive Committee. All officers shall be elected by the Congregation for a term of one year at the annual meeting of the Congregation with the term to commence the following June 1st.

Section 2. The duties of the President shall be: to preside at all meetings of the Congregation, of the Board of Trustees and of the Executive Committee; when authorized by the Board of Trustees, to negotiate all legal documents or agreements of the Congregation, including employment agreements; to call special meetings of the Congregation, the Board of Trustees and the Executive Committee; to sign all legal documents on behalf of the Congregation; to form, all task forces and working groups to study particular matters and to report back to the Executive Committee and/or the Board of Trustees; and to appoint all committee chairs. The President shall be an ex-officio member of all committees except the Nominating Committee. The President shall also perform all other duties incident to the office.

Section 5. The Finance Director shall report monthly to the Executive Committee and the Board of Trustees, and annually to the entire Congregation, on the financial condition of the Congregation. The Finance Director shall chair or serve on the Budget and Finance Committee and monitor the variances between actual operating income and expenses and the budget. The Finance Director shall serve on other committees pertaining to development and fundraising, and serve on other committees, task forces and working groups pertaining to development and fundraising as determined by the President; and to perform all other duties incident of the office.

Section 6. The Treasurer shall be the custodian of all funds of the Congregation and shall be responsible for overseeing the accounting for receipts and disbursements and the maintenance of proper books and other financial books and records as necessary. The Treasurer shall oversee the functions pertaining to dues collection and dues reductions and perform all other duties incident of the office. At the direction of the President, the Treasurer shall chair or serve on other committees directly involving financial matters of the Congregation.

Section 7. If, in the determination of the Board of Trustees, additional officers become necessary to meet specific needs of the Temple, the Board of Trustees may from time to time create such positions and define the duties of the persons serving in them. Such officer(s) shall serve for only a one year term(s), and shall be selected in accordance with Article 4 hereof.¹

¹ This would be inserted and the numbering rearranged for the remainder of the article.

Constitution Evolution (con't)

Section 10. It shall be the duty of the Executive Committee to assist and advise the President and the Board of Trustees. The Executive Committee by majority vote shall have the authority to approve an expenditure not provided for in the annual budget approved by the Congregation, provided (a) the amount of such non-budgeted item does not exceed \$1,000 and (b) the amount of such non-budgeted item plus the aggregate amount of all non-budgeted items previously approved by the Executive Committee during the fiscal year of the Congregation does not exceed one percent (1%) of the total amount of expenditures set forth in the annual budget approved by the Congregation for such fiscal year. All non-budgeted items approved by the Executive Committee shall be reported to the Board of Trustees at the next meeting of the Board of Trustees.

Section 11. The Executive Committee may organize committees, task forces, and working groups in a manner that it determines best serves the congregation.

Most of these proposed changes are for the purpose of efficiency and to align us with what we are currently doing because the constitution and bylaws does not address the matter at all. As an example, the president signs legal documents (such as employee contracts), but the current constitution and bylaws does not say that the president can negotiate the contracts – obviously someone has to negotiate for the temple! Likewise, the finance director, like other officers, should be able to be added to other committees as deemed appropriate.

The change to section 1 and the addition of section 7 permits the board to create additional officer positions should the need arise. These positions would serve for one year, and would become positions elected by the congregation.

Section 10 is currently in our constitution verbatim, but found in article 8, which makes no sense, since article 8 talks about appointed committees, and this section talks about the executive committee (meaning officers).

Finally, section 11 simply gives the executive committee the authority to organize the many committees, task forces, and working groups in an efficient manner. Currently, it is unknown who, if anyone, has the authority to organize the many groups, but instead lets the president just name the chairs.

As always, do you like or object to the proposed alternative version/additions? Do you have any grammatical or substantive suggestions for improving either version or a completely different version you would like to propose? Please share these thoughts with me this month so I can share your thoughts with the board.

If you still have not yet looked at the temple's website, please view the section on [Constitution Evolution](#) to see our progress on this issue. The Board of Trustees approved at its previous meetings proposed amendments to be taken to the congregation. B'nai Mitzvah Revolution

In mid-November, Rabbi Paley, congregant Deb Levy and I attended the introductory workshop of the *B'nai Mitzvah Revolution*. Prior to leaving for the workshop in Maryland, the BMR team met to complete our preparatory assignments.

As part of those assignments, we identified our revolutionary project on which we would like to focus our attention for enhancing and improving the B'nai Mitzvah experience at Temple Shalom. The project will be to create a mentor program for our families whose responsibilities will be to shepherd our congregants through their lifelong learning journey. When this program is fully implemented – five years down the road – mentors will meet with every congregant within two weeks of joining the Temple and then periodically throughout their time here at Temple. Some of the goals of the mentor meetings will be to plan the families' Lifelong Learning journey, discuss the B'nai Mitzvah experience and work to make it meaningful for the family and the congregation, and to chart the families' post B'nai Mitzvah involvement. This is a very early and general vision of the program. We anticipate that it will include family education programs, alternative T'fillah experiences, mitzvah projects, and much more.

In January and February, we plan to hold several small focus groups to work to identify our common and shared values around the idea of Bar/Bat Mitzvah. We want to begin this project with a clear sense of what is important to our congregants of every age and demographic regarding Bar/Bat Mitzvah. During those months, we will also work to define the characteristics of the mentors we will be seeking. Information about these focus groups will be sent out in December by email. If you are interested in participating, please email me and I will make sure you are included.

All of us on the BMR team are very excited about the possibilities in store for our congregation. We hope that you will join us with your enthusiasm and support.

IS THIS A GOOD TIME FOR CHARITABLE GIVING?

Charitable giving can play an important role in many estate plans. Philanthropy cannot only give you great personal satisfaction, it can also give you a current income tax deduction, let you avoid capital gains tax, and reduce the amount of taxes your estate may owe when you die.

There are many ways to give to charity. You can make gifts during your lifetime or at your death. You can make gifts outright or use a trust. You can name a charity as a beneficiary in your will, or designate a charity as a beneficiary of your retirement plan or life insurance policy. Or, if your gift is substantial, you can establish a private foundation, community foundation, or donor-advised fund.

Making outright gifts

An outright gift is one that benefits the charity immediately and exclusively. With an outright gift you get an immediate income and gift tax deduction.

Will or trust bequests and beneficiary designations

These gifts are made by including a provision in your will or trust document, or by using a beneficiary designation form. The charity receives the gift at your death, at which time your estate can take the income and estate tax deductions.

Charitable trusts

Another way for you to make charitable gifts is to create a charitable trust. You can name the charity as the sole beneficiary, or you can name a non-charitable beneficiary as well, splitting the beneficial interest (this is referred to as making a partial charitable gift). The most common types of trusts used to make partial gifts to charity are the charitable lead trust and the charitable remainder trust.

Charitable lead trust

A charitable lead trust pays income to a charity for a certain period of years, and then the trust principal passes back to you, your family members, or other heirs. The trust is known as a charitable lead trust because the charity gets the first, or lead, interest.

A charitable lead trust can be an excellent estate planning vehicle if you own assets that you expect will substantially appreciate in value. If created properly, a charitable lead trust allows you to keep an asset in the family and still enjoy some tax benefits.

Charitable remainder trust

A charitable remainder trust is the mirror image of the charitable lead trust. Trust income is payable to you, your family members, or other heirs for a period of years, then the principal goes to your favorite charity.

A charitable remainder trust can be beneficial because it provides you with a stream of current income—a desirable feature if there won't be enough income from other sources.

Private family foundation

A private family foundation is a separate legal entity that can endure for many generations after your death. You create the foundation, then transfer assets to the foundation, which in turn makes grants to public charities. You and your descendants have complete control over which charities receive grants. But, unless you can contribute enough capital to generate funds for grants, the costs and complexities of a private foundation may not be worth it.

Community foundation

If you want your dollars to be spent on improving the quality of life in a particular community, consider giving to a community foundation. Similar to a private foundation, a community foundation accepts donations from many sources, and is overseen by individuals familiar with the community's particular needs, and professionals skilled at running a charitable organization.

Donor-advised fund

Similar in some respects to a private foundation, a donor-advised fund offers an easier way for you to make a significant gift to charity over a long period of time. A donor-advised fund actually refers to an account that is held within a charitable organization. The charitable organization is a separate legal entity, but your account is not—it is merely a component of the charitable organization that holds the account. Once you transfer assets to the account, the charitable organization becomes the legal owner of the assets and has ultimate control over them. You can only advise—not direct—the charitable organization on how your contributions will be distributed to other charities.

Likely reduction of itemized deductions in 2013

Prior to 2010, there were provisions to phase out certain itemized deductions, including charitable donations, for those whose income surpassed certain thresholds. After 2012, unless Congress acts, your itemized deductions may once again be phased out. If this provision is reinstated in 2013, itemized deductions will be generally reduced by 3% of the excess of your adjusted gross income over the threshold amount (\$166,800 in 2009). As much as 80% of your allowable itemized deductions can be eliminated.

Motivations for charitable giving are personal and unique, and the most appropriate strategies will depend on your individual and family goals. It is important to discuss your charitable giving goals and strategies with tax, legal, and investment advisors.

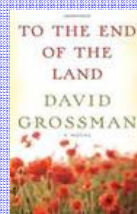
