Welcome Rabbi Ariel Boxman!

Rabbi Ariel Boxman grew up in the Carriibbean on the island of St. Thomas. As the daughter of a Reform rabbi, Rabbi Boxman was an active participant in the Reform Movement. She spent twelve years at Camp Eisner, a URJ camp in Great Barrington, Massachusetts, as a camper, counselor and education specialist. Rabbi Boxman's passion for Israel, Israeli culture and Hebrew is demonstrated by her numerous trips to Israel, including her participation in two study-abroad programs – The Hebrew University of Jerusalem in 2005 and the NFTY-Eisendrath International Exchange in 2002.



In 2007, Rabbi Boxman graduated from American University in Washington D.C., with a major in International Relations and a minor in Israel Studies. With a passion for Jewish leadership, pastoral care and education, she continued her studies at the Hebrew Union College and was ordained as a rabbi in 2012. I Was Just Thinking...



Last month, The United States Supreme Court overturned a key part of the 1996 Defense of Marriage Act, which mandated that federal laws abide by a definition of marriage as between a man and a woman, and ruled that the people who sought to overturn a California Supreme

Court decision recognizing same-sex marriage had no standing to sue. It was, indeed, an incredible landmark decision filled with emotions on both sides of the ruling. Religious traditions, including Judaism, have long held opinions about homosexuality. How do we understand this ruling according to Jewish tradition?

Some have argued that Torah prohibits male homosexuality for sure and perhaps, lesbian sexuality as well. Others have argued that the ambiguity of "You shall not lie with a man as with a woman" (Is this physically possible?) leaves open to question what the text really means. But, I think we need to look more deeply at the Torah and to try and understand its intentions. To be sure, what the Torah commands us to do and how the rabbis of the Talmud interpret those commands are often quite different and seemingly contrary to each other. For example, the Torah provides for capital punishment in a variety of circumstances. The rabbis, however, consider any religious court that would execute someone once in seven years to be brutal. Other rabbis went so far as to say that once in 70 years is brutal. Capital punishment almost never happened.

Today all human cultures -- indeed the planet as a whole, including its many life forms -- are living through an even deeper earthquake. Biblical Judaism, out of which sprang the Leviticus prohibition on homosexuality, professed three basic rules for proper sexual ethics: 1. Men were in charge; 2. It was crucial to have as many children as possible; 3. Sex was delightful and sacred; celibacy was almost unheard of, and almost always strongly discouraged.

These were affirmed in many halakhic contexts as well as in the basic underlying mythic value-system. How did these affect attitudes toward homosexuality? If a man had to be in charge in a sexual relationship, there was no way to deal with a relationship of two men. Neither one could be subordinated -- "as with a woman." Such a relationship would destroy all the circuits. Conversely, a relationship between two

"subordinate" women would not even register as possible -- and so it was ignored in biblical tradition.

Is the statement, "be fruitful; and multiply," intended by Torah to persist forever? No more than the twin statement that human beings (or at least men) shall "work in the sweat of their brow," wringing a livelihood from a hostile earth. Both these statements were about a history that should be transcended, not an edict to be obeyed. So what about "be fruitful and multiply"? What shall we do in a generation when, indeed, we human beings have "filled up the earth and subdued it," when the sheer number of humans is putting impossible burdens on our global ecosystem and plunging into extinction thousands of the species that God commands in the story of the Flood that we must not allow to die? Modernity has transformed the world we

live in. The Modernity that eases our work and makes women and men equal and brings the human race to fill up and subdue the earth may even be what God intended.

So then we must ask ourselves, what must we change in our new world? In a world where men are not required to be dominant nor women to be subordinate, a relationship of two men or two women need not be either

destructive or irrelevant. In a world filled and subdued by the human race, multiplying our numbers may actually contravene God's intention, and we might now read the command as teaching us to be fruitful and expansive, emotionally, intellectually, and spiritually rather than biologically.

The third basic rule -- that sex is delightful and sacred -- still stands. The biblical Song of Songs embodies it, and the Song may point beyond the Eden of the past, of a childish human race, past our history of toil and hierarchy, toward an Eden of the Future -- "Eden for grown-ups," for a grown-up human race and for newly mature individual human beings.

Having had the honor of officiating at many weddings of same-sex couples since 1993, I reaffirm for myself the idea that we are all created in God's image and that healthy, committed relationships that honor one another, honor God and the Jewish people. I am grateful that our Justices have seen this as well. Thus, from a spiritual, as well as a legal standpoint, the Supreme Court of the United States has opened the way to enhancing, not destroying, marriage. It has opened the gates; but only spiritual communities can enter. Let the tents of Jacob and the shrines of Israel rejoice, "Mah tov! How wonderful!"

At the conclusion of the performance, we will proceed into the Sanctuary for our Selichot service.



CONSTITUTION EVOLUTION UPDATE

The Temple Shalom Board of Trustees wants to thank our congregation for helping it review our Constitution and Bylaws. While we all want the best Constitution and Bylaws for our congregation, *the process matters more than the outcome*. We have held two town hall meetings, received monthly input from congregants, and posted monthly articles in the Temple Bulletin. The Board has reviewed and considered all of your comments, and has now approved the proposed amendments below to be considered by the Congregation. What is marked up below is the current constitution with the proposed changes. The current constitution and all of the currently proposed amendments can also be found on the temple's website at <http://www.templeshalomdallas.org/about-us/2013-01-23-22-36-45/constitution-bylaws>.

By **August 25, 2013**, you should send any further comments, edits, or proposed amendments to the Board. We will compile the final comments, then let the Board take one final vote on the proposals and circulate a final version of the proposed amendments to all congregants.

On **October 27**, we will have a congregational meeting to vote on the final proposed amendments. According to the current Constitution, the congregation is entitled to review any proposed amendments at least 21 days before a vote on an amendment:

Amendments to the Constitution and Bylaws shall be presented in writing and shall be proposed by the Board of Trustees or by at least ten regular members of the Congregation, and shall be filed with the secretary. Such amendments may be acted on at any regular meeting of the Congregation or at any special meeting called for that purpose. Copies of the proposed amendments shall be mailed to each member along with the notice of the meeting at least twenty-one days prior thereto. An affirmative vote of two-thirds of the voting members of the Congregation present at a duly called Congregation meeting shall be necessary to adopt any amendment.

The proposed amendments as currently drafted are as follows (the italics is a proposed change, the strike through is a removal of words, an underline is an addition):

ARTICLE II

MISSION STATEMENT: To inspire in our congregation an enduring relationship with God, Torah and the Jewish people through communal worship, study, gathering and community service.

Section 1. The purpose of Temple Shalom is to enable all of its members to develop a relationship with God, Torah and the Jewish people through communal worship, study and assembly. Temple Shalom will function in an inclusive and egalitarian atmosphere. To ensure the continuity of the Jewish people, Temple Shalom shall promote the education of the fundamental and enduring principles of Judaism as understood and practiced by the Reform Movement, and apply those principles to the values and conduct of the individual, the family and the society in which we live and participate. In order to advance the cause of Reform Judaism in America, in Israel and throughout the world, Temple Shalom shall affiliate itself with the Union for Reform Judaism, herein referred to as URJ.

Section 2. Temple Shalom shall be operated as a tax exempt organization under Section 501c(3) of the Internal Revenue Code.

ARTICLE IV

Section 5. The Board of Trustees shall be responsible for overseeing the management of the general management of the affairs, funds, records and property of the Congregation. The Board of Trustees shall act on all matters of policy, fill all vacancies in its personnel until the next Congregational election, and perform such other duties as the members of the Congregation in regular or special meetings assembled from time to time may prescribe.

~~Section 6. The Board of Trustees shall have the authority to engage, and to terminate the engagement of, an Executive Director of the Congregation, a Director of Religious Education, a Director of Life Long Learning, a Director of Early Childhood Education and any other employees of the Congregation, with such duties and responsibilities as determined from time to time by the Board of Trustees. The engagement or termination of engagement of the Director of Religious Education the Director of Life Long Learning and the Director of Early Childhood Education and the determination of the duties and responsibilities of the Director of Religious Education the director of Life Long Learning and the Director of Early Childhood Education shall be made in consultation with the Senior Rabbi.~~

Section 67. The Board of Trustees shall have the power: to engage and to terminate the engagement of any contract employee of the Congregation (except for hiring or termination of a full-time Senior Rabbi pursuant to Article 6 Section 1), to manage all properties, real and personal, belonging to the Congregation; to establish the functions, duties, and responsibilities of all employee and staff positions of the Congregation, including clergy; to approve or reject any legal documents or agreements negotiated by the President on behalf of the Congregation; to sell, lease, rent, convey, mortgage or pledge any real estate, bonds, securities or other property; to borrow money; to execute and deliver notes evidencing such borrowing and mortgages or pledges in order to secure the same; to invest and reinvest any funds belonging to the Congregation; and to delegate to any officer or officers of the Congregation the power and authority to execute and deliver in the name of the Congregation all documents necessary or appropriate to carrying out the foregoing powers. The Board of Trustees, upon a vote of three-fourths (3/4ths) of the members of the Board of Trustees present at a duly called meeting, shall have the authority to expend funds for any matter not included in the annual budget of the Congregation or in excess of a budgeted amount.

ARTICLE V

OFFICERS AND THEIR DUTIES

Section 1. The officers of the Congregation shall consist of a President, three Vice-Presidents, a Secretary, a Financial Director and a Treasurer. All officers must be a member of the Board of Trustees at the time of nomination or have been a member of the Board of Trustees within the previous three (3) years, be a member in good standing of the Congregation and be of the Jewish faith. The Officers, together with the Immediate Past President, shall constitute and serve as the Executive Committee. All officers shall be elected by the Congregation for a term of one year at the annual meeting of the Congregation with the term to commence the following June 1st.

Section 2. The duties of the President shall be: to preside at all meetings of the Congregation, of the Board of Trustees and of the Executive Committee; when authorized by the Board of Trustees, to negotiate all legal documents or agreements for the Congregation, including employment agreements; to call special meetings of the Congregation, the Board of Trustees and the Executive Committee; to sign all legal documents on behalf of the Congregation; to establish all task forces and working groups to study particular matters and to report back to the Executive Committee and/or the Board of Trustees; and to appoint all committee chairs. The President shall be an ex-officio member of all committees except the Nominating Committee. The President shall also perform all other duties incident to the office.

Section 5. The Finance Director shall report monthly to the Executive Committee and the Board of Trustees, and annually to the entire Congregation, on the financial condition of the Congregation. The Finance Director shall chair or serve on the Budget and Finance Committee and monitor the variances between actual operating income and expenses and the budget. The Finance Director shall serve on other committees pertaining to development and fundraising as determined by the President; and to perform all other duties incident to the office.

Section 6. The Treasurer shall be the custodian of all funds of the Congregation and shall be responsible for overseeing the accounting for receipts and disbursements and the maintenance of proper books and other financial books and records as necessary. The Treasurer shall oversee the functions pertaining to dues collection and dues reductions and perform all other duties incident to the office. At the direction of the President, the Treasurer shall chair or serve on other committees directly involving financial matters of the Congregation.

Section 9. It shall be the duty of the Executive Committee to assist and advise the President and the Board of Trustees. The Executive Committee by majority vote shall have the authority to approve an expenditure not provided for in the annual budget approved by the Congregation, provided (a) the amount of such non-budgeted item does not exceed \$1,000 and (b) the amount of such non-budgeted item plus the aggregate amount of all non-budgeted items previously approved by the Executive Committee during the fiscal year of the Congregation does not exceed one percent (1%) of the total amount of expenditures set forth in the annual budget approved by the Congregation for such fiscal year. All non-budgeted items approved by the Executive Committee shall be reported to the Board of Trustees at the next meeting of the Board of Trustees.

Section 10. The Executive Committee may organize committees, task forces, and working groups in a manner that it determines best serves the congregation.

ARTICLE VIII

Section 1. The following standing committees shall be appointed by the President at the first meeting of the Board of Trustees following the annual meeting of the Congregation. Each committee shall consist of at least three members, including the chair. The action of each committee will always be subject to the approval of the Board of Trustees.

Budget and Finance Committee

Building and Grounds Committee

Cemetery Committee

Early Childhood Education Committee

Legal Committee

Membership Committee

Religious School Committee

Worship Committee*

~~Section 10. It shall be the duty of the Early Childhood Education Committee to advise the Director of Early Childhood Education as to the policies and procedures necessary or appropriate for the governance of the Early Childhood Education Program. The Early Childhood Education Committee shall recommend to the Board of Trustees whether a Parent Teacher Organization should be established for the Early Childhood Education Program. The Board of Trustees shall have the exclusive authority to approve the establishment and bylaws of such Parent Teacher Organization.~~

Section 14. A majority of the members of the Board of Trustees present at a duly called meeting may designate, from time to time, such other committees with such duties, responsibilities, purposes, membership and duration as determined by the Board of Trustees.

~~Section 12. There shall be an Executive Committee consisting of the President, the Vice President, the Secretary, the Financial Director, the Treasurer and the Immediate Past President. It shall be the duty of the Executive Committee to assist and advise the President and the Board of Trustees. The Executive Committee by majority vote shall have the authority to approve an expenditure not provided for in the annual budget approved by the Congregation, provided (a) the amount of such non-budgeted item does not exceed \$1,000 and (b) the amount of such non-budgeted item plus the aggregate amount of all non-budgeted items previously approved by the Executive Committee during the fiscal year of the Congregation does not exceed one percent (1%) of the total amount of expenditures set forth in the annual budget approved by the Congregation for such fiscal year. All non-budgeted items approved by the Executive Committee shall be reported to the Board of Trustees at the next meeting of the Board of Trustees. * (THIS HAS BEEN PROPOSED TO BE MOVED TO ARTICLE V ABOVE)~~

Section 13. The chairperson of each Committee established under this Article 8 must be a member in good standing of the Congregation and be of the Jewish faith.

ARTICLE IX

CONGREGATIONAL MEETINGS

Section 1. The annual meeting of the Congregation shall be held in the month of May. At this meeting, reports shall be submitted by the President, by the Senior Rabbi and by any auxiliaries or committees as scheduled by the Board of Trustees. In addition, an annual budget of the Congregation for the coming fiscal year shall be approved by majority vote of the voting members of the Congregation present at the annual meeting at which a quorum is present. Every member of the Congregation shall be notified of the meeting and the location thereof by mail at least twenty one days prior to the meeting date. *The term 'mail' throughout this constitution shall be defined to include but not be limited to postal or electronic mail.*

Section 2. Special meetings of the Congregation may be called by the President, or at the request of a majority of the Board of Trustees, or on written application of at least twenty-five ~~regular~~ members units of the Congregation. The call for a special meeting shall set forth the purpose of the meeting and written notice thereof shall be mailed to all members at least seven days prior to the time of such meeting; no business shall be transacted except that specified in the call.

Section 3. The number of voting members units of the Congregation constituting a quorum at meetings of the Congregation shall be equal to five percent (5%) of the number of eligible voting member units of the Congregation, as most recently determined by the Secretary of the Congregation in accordance with Article 3. For example, if the number of units of voting members ~~regular membership~~ of the Congregation is 1,000, 50 (5% of 1,000) voting members units must be present at a Congregation meeting to constitute a quorum at such meeting.

Section 4. For the Congregation to undertake any of the following acts, a vote of not less than two-thirds of voting members of at least twenty-five percent of the voting member units then in good standing, as defined in Article V hereof, shall be required: (i) relocation of the Congregation from 6930 Alpha Road, Dallas, Texas to another permanent location; (ii) sale or long term lease of the property or building at 6930 Alpha Road, Dallas, Texas; (iii) incurring indebtedness of a cumulative principal equal to or in excess of fifty percent of the budgeted, annual revenue of the Congregation at the time the indebtedness is incurred; (iv) de-affiliation with, or withdrawal of the Congregation from, Reform Judaism or the URJ; (v) merger of the Congregation with any other group, congregation or religious organization; (vi) dissolution of the Congregation; (vii) execution of any employment contract for a primary term exceeding ten years; or (viii) amendment to or suspension of this Article. For example, if the number of units of regular membership of the Congregation is 1,000, at least 250 (25% of 1,000) must be present at the meeting to undertake the specified acts; then, a vote of 2/3 of the voting members present is required to undertake the listed acts.

ARTICLE X

NOMINATIONS AND ELECTIONS

Section 6. Election shall be by secret ballot. If the slate presented by the nominating committee is unopposed, ~~the secretary may be instructed to cast a single ballot for~~ the slate may be approved by acclamation.

ARTICLE XV

RULES OF ORDER

The rules of procedure at meetings shall be determined by Roberts Rules of Order, latest revised edition. The President shall have the authority to appoint ~~from among the Board of Trustees an individual congregant~~ to serve as parliamentarian of the Board of Trustees. Only persons authorized to participate in a closed meeting or Executive Committee meeting may be selected as parliamentarian for such a meeting.

ARTICLE XVI

Amendments to the Constitution and Bylaws shall be presented in writing and shall be proposed by the Board of Trustees or by at least ~~twenty~~ regular members units of the Congregation, and shall be filed with the Secretary. Such amendments may be acted on at any regular meeting of the Congregation or at any special meeting called for that purpose. Copies of the proposed amendments shall be mailed to each member, along with the notice of the meeting, at least twenty-one days prior thereto. No motion that will modify a proposed amendment, or substitute another amendment, will be acted on unless the proposal or substitution complies with the notice requirements of this Article. An affirmative vote of two-thirds of the voting members of the Congregation present at a duly called Congregation meeting shall be necessary to adopt any amendment.


ARTICLE XVIII

In case of the liquidation, dissolution or winding up of the Congregation, whether voluntary, involuntary or by operation of law, the assets, monies or properties of the Congregation shall be distributed in such manner as the Board of Trustees shall direct; provided, however (i) that any such distribution shall be made exclusively to carry out the purposes for which the Congregation is formed; (ii) that any such use or distribution of the assets, monies or properties of the Congregation shall be in accordance with Article I, Section 2, and Article II, of this Constitution and, to the fullest extent possible, shall promote similar or related purposes; (iii) that no person, Officer, Trustee, employee or representative of the Congregation shall be entitled to any distribution or division of the Congregation's properties, assets or monies; and (iv) that any such distribution or division shall comply with the applicable requirements for such distributions or divisions for tax exempt organizations under 501c(3) of the Internal Revenue Code, as amended, or any similar federal statute then in effect, and the rules and regulations pursuant thereto.




