Board Appointee: Dennis Eichelbaum stated Elise Donosky had resigned from the Board for personal reasons. He stated the nominating committee had nominated Renee Roth to fill in for the rest of the Board term.

Lory Kohleriter made the motion: I move to appoint Renee Roth to fill the current board vacancy through the end of May 2023.

Jody Pearson seconded the motion. The motion passed unanimously.

Board Members and Past Presidents were asked to go to the sanctuary where photos were taken.

HR Staffing Task Force (closed session): David Mersky and Michael Jaffe of Mersky, Jaffe, and Associates presented their findings related to the HR Staffing scan and made recommendations on staffing structure and the new Executive Director job description. The HR Staffing Task Force, led by Julie Eichelbaum, gave a follow-up presentation making recommendations based on their assessment of the Mersky and Jaffe report. Members of the HR Staffing Task Force included: Julie Eichelbaum, Co-Chair, Gail Enda, Co-Chair, Josh Goldman, Bob Landers, Diane Laner, Theresa Myers, Raelaine Radnitz, and Debbi Sorrentino.

New Search Task Force (to replace Steve Lewis): Dennis thanked the HR Staffing Task Force for their work and announced a new Executive Director Search Task Force. Task Force members include Julie Eichelbaum Gail Enda, Karen Fishkind, Josh Goldman, Stephanie Hirsh, Bob Landers, Theresa Myers, Rabbi Paley, Raelaine Radnitz, and Ali Rhodes.

Mercy Church Lease: Dennis announced that Mercy Church's lease with Temple Shalom expires this year. They are seeking a three-year contract with the following terms:

- Year one: 11.5 percent increase (an annual increase of \$9,000 over current lease).
- Year two: additional 5% increase (\$4,050 over prior year)
- Year three: additional 5% increase (\$4,252 over prior year).

Jason Gadsby made the motion: I move to authorize the President to negotiate and sign a three-year contract extension with Mercy Church. Mark Stromberg seconded the motion. The motion passed unanimously.

Annual Membership Suspensions: Steve Lewis reviewed the membership suspension report that was provided to the Board in advance of the meeting with the Board. He noted that the list was very minimal in comparison to prior years. Joel Guskin made the motion: *I move to suspend the members as listed in the proposed suspension report four of the six*). Robyn Klein seconded the motion. The motion passed unanimously.

Fundraisers for 2023-2024: Theresa Myers gave a demonstration about the HundredX fundraiser. Goal: \$15K. Each opinion given provides \$1.60 in revenue to Temple Shalom. Last year, the HundredX campaign raised ~\$6K. The campaign runs from February 6 – March 6, 2023.

Budget Committee: Jason Gadsby stated the deadline for committees to submit their 2023-2024 budgets was in two weeks. He asked the Board members to work with their committees and ensure the proposed budgets were completed and emailed to the Budget Committee as soon as possible.
